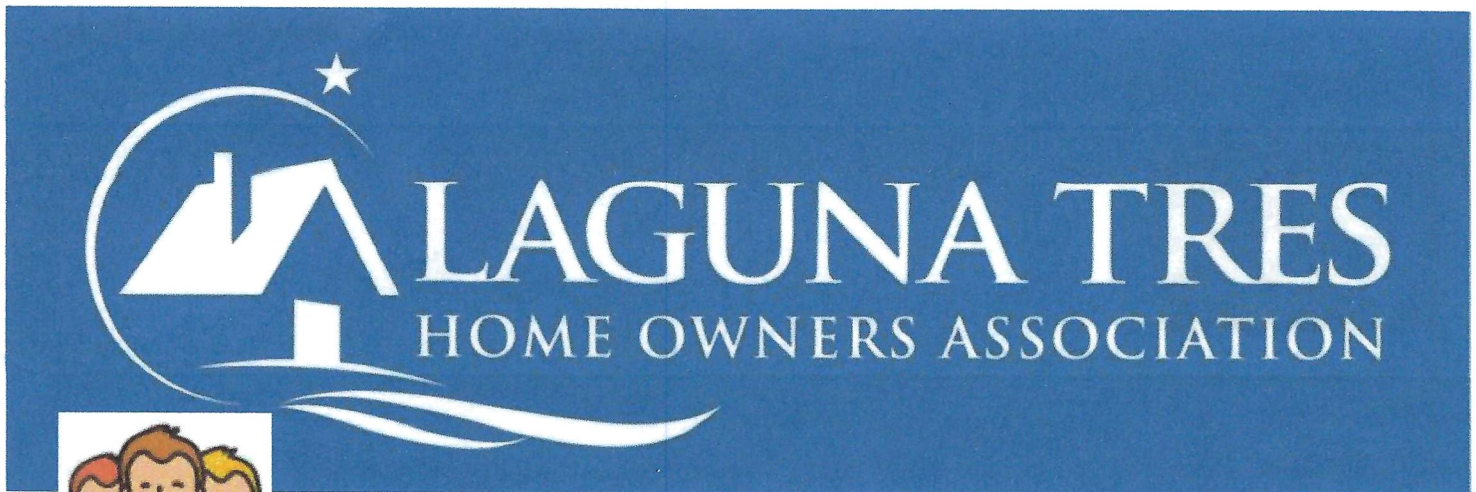




Laguna Tres HOA
